

Official Contest Rules

I have read the OFFICIAL CONTEST RULES for the AVID T-Shirt Design contest and I agree to all the rules and regulations of the contest as outlined below:

1. The contest is open to current AVID students and alumni.
2. The designs must **incorporate AVID's brand**.
3. Contestants warrant that their designs are original creations of the contestant. The design must never have been published and cannot contain profanity, trademarks, logos, or copyrighted works of any other person, business or entity.
4. The single prize is one gift card for \$250.
5. All entries become and remain the property of AVID in perpetuity. AVID will retain the exclusive rights to reproduce, prepare derivative works, distribute and display the winning design after the contest closes. Contestants may display their own design(s) in a portfolio or personal collection, but may not sell or reproduce the design(s) for any other purpose once submitted to the contest. No designs or entries will be returned.
6. AVID Center may produce and sell t-shirts on the AVID eStore at events or through other means, with the winning design, but is not obligated to do so. No royalty payment will be paid to the designer under any circumstances.
7. A panel of AVID judges will choose the top submissions. AVID Center Staff will vote for the winner out of these finalists.
8. The contest begins on November 1, 2017.
9. The entries must be received through the submission form by 11:59 p.m. PST on Friday, December 17, 2017.
10. FORM OF ENTRIES:
 - o The entry must be accompanied by your name and contact information.
 - o The entry may be drawn or printed on 8-1/2" x 11" **paper or the entry may be any of the following art file formats if submitted electronically: .AI, .JPG, .PDF, .PNG or .PSD**. If the winning design is hand drawn, we may request the original artwork.
 - o **AVID's brand colors should be incorporated in the design**.
 - o All words and design features must be original and not infringe upon any existing copyright.
 - o Official AVID logos and marks are prohibited from use in the design. Contestants may incorporate a sketch or semblance of the logo to indicate where they would like the logo to be included in the design. **AVID Center's Creative Services team will select the best placement for the AVID Logo on the winning design.**
11. AVID Center reserves the right to pick one entry, more than one entry, or no entries as the winning entry.
12. If an entry is chosen as the winning entry, the designer will receive a \$250 gift card.
13. AVID Center may produce and sell t-shirts on the AVID eStore, at events or through other means, with the winning design, but is not obligated to do so. No royalty payment will be paid to the designer under any circumstances.
14. AVID Center reserves the right to terminate this contest at any time, effective on the date of issuing the termination notice without giving notice prior to the date of termination.
15. All contestants will sign an assignment and release form acknowledging the acceptance and understanding of the complete contest rules.
16. This contest is subject to California State Law.
